



Performance Level Descriptors (PLDs) describe the knowledge, skills, and practices that students should know and be able to demonstrate at each Performance Level in each content area (ELA and mathematics) and at each grade level/course.

## EDUCATIONAL ENVIRONMENTS FOR STUDENTS WITH DISABILITIES

Research has shown that students with disabilities who received their special education and/or related services in the general education environment displayed increased motivation, higher self-esteem, improved communication and socialization skills, and greater academic achievement as compared to students who received their special education and/or related services in a more restrictive, or segregated, environment.

The educational environments in which students with disabilities ages 6-21 receive their special education and/or related services are generally classified into four settings:

- 1. Served inside the general education classroom 80% or more of the day
- 2. Served inside the general education classroom 40% to 79% of the day
- 3. Served inside the general education classroom less than 40% of the day
- 4. Served in separate educational facilities

The following information is provided for students ages 6 through 21.
